#### IP COMMISSION MEETING IN DELHI, NOVEMBER 2016



The Commission had a constructive dialogue with senior Indian government officials on the implementation of the Indian National IP Strategy in New Delhi. The meeting was followed by a conference on "IP: Key Enabler to Growth & Innovation" organised by ICC India and FICCI.

## REPORT ON SPECIALISED IP JURISDICTIONS PRESENTED TO WIPO ACE

Eugene Arievich, one of the lead drafters of the report, presented the IP Commission report on SIPJs during a session on IP Courts of WIPO's Advisory Committee on Enforcement (ACE) on 6 September.

## **NEW PROJECTS IN 2017...**

As part of this year's action plan, the commission will start work on:

- Patent quality and work sharing by examining the impact of work sharing and other patent office
  efficiency initiatives on patent quality;
- **Design protection for graphical user interfaces** by making recommendations on their practical and legal aspects in different jurisdictions;
- Valuation and monetization knowledge compendium by compiling information and practices on the monetary valuation of IP assets across different professions;
- Recent trade secrets legislation in the EU and in the US by conducting a comparative analysis from the legal and business perspectives;
- **Procedural formalities relating to IPR registration**, e.g through the Apostille Convention, by encouraging governments to reduce or abolish them;
- **Utility models** by surveying the current state of utility model protection worldwide and company best practices on dealing with utility models.
- EU Unitary Patent and Unified Court by identifying and advocating solutions which preserve the interests of businesses inside and outside the EU and the UK after Brexit.



ICC played an active role in representing the business community in access and benefit sharing discussions, including:

- Advisory Committee on Enforcement (ACE): presentation of the report on specialised IP jurisdictions

ICC also continued to participate in the WIPO Green Steering Committee and its informal network on the Madrid Agreement.
